The Mare Owner/Agent/Agent agrees to pay a breeding fee of **\$1250.00** which includes a \$500.00 non-refundable booking fee. First Fedex shipment is free.

The balance of the entire breeding fee is due prior to first shipment of semen or insemination of mare. All payments must be made payable to Weber Performance Horses herein referred to as WPH.

**HERDA Statement:**

Hereditary equine regional dermal asthenia (HERDA) is a genetic skin disease predominately found in the American Quarter Horse. HERDA has an autosomal recessive mode of inheritance and affects mares and stallions in equal proportions. It is the policy of the stallion owner and WPH not to breed HERDA carriers to each other due to a 25% chance of producing a clinically affected offspring. It is strongly recommended that all mares being considered for breeding to a carrier stallion be tested for HERDA prior to execution of this contract. The stallion owner and WPH will not assume liability or financial responsibility, including breeding and service fees, if a carrier (N/HRD) mare is bred to a carrier (N/HRD) stallion.

The following conditions of service (for which there will be no exceptions) are mutually agreed between the Mare Owner/Agent, named above, and WPH, as agents for the above Stallion, upon the execution of this contract:

**Pre-Breeding Arrangements:**

The Mare Owner/Agent must provide the following to WPH when making a booking:

1. Copy of both sides of Registration Certificate.
2. Completed Shipped Semen Form (if applicable).
3. Copy of Signed Breeding Contract
4. ALL applicable fees.
  - The booking fee is due in full at submission of signed contract;
  - ALL Stallion Fees must be paid in full a minimum of 7 business days before any cooled semen can be picked up or shipped (where applicable);
  - Any incomplete registration certification or unpaid charges will result in a hold being placed on the mare's name on the appropriate stallion breeding report.
  - Unless shipping has been prepaid, by check or US money order, shipped semen (if applicable) will not be shipped to any mare unless a current credit card number, expiration date and security number is on file with WPH.

**Breeding Arrangements:**

1. Mare Owner/Agent must give a minimum of 48 hour advance notice of possible semen shipment (if applicable) to WPH and confirm shipment 24 hours prior to actual shipment.
2. Every effort will be made to accommodate Mare Owner/Agent's breeding time frame. However, it is the Mare Owner/Agent's responsibility to ensure that WPH has up to date information at all times throughout the process. In doing so, you are facilitating the insemination process. Failure to

adhere to these arrangements may result in missed heats and delayed shipments (where applicable) at the Mare Owner/Agent's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations in order to maximize the potential of a timely pregnancy.

3. If a mare dies, or is deemed unfit to breed, during the breeding season (a veterinarian report will be required as verification) a substitute mare, owned by the same Owner and approved by WPH, may be bred without any additional breeding fee.
4. Confirmation of pregnancy by ultrasound starting at 14 days post ovulation continuing through to the 45th day of pregnancy is REQUIRED TO MAINTAIN THE LIVE FOAL GUARANTEE. If ultrasound is unavailable, Mare Owner/Agent agrees to have the mare checked for pregnancy by licensed veterinarian within 30 days of insemination.
5. Mare Owner/Agent agrees to provide the results of the ultrasound(s)/pregnancy exam(s) to WPH no later than 30 days following insemination.
6. Live foal guarantee. A live foal is defined as one that will stand and nurse. If foal is born dead, Mare Owner/Agent agrees to furnish a veterinarian's certificate describing the occurrence to WPH within 7 days. In such a case return privileges will be available for one year only. Re-breeds must pay the fee applicable for the re-breed year and any relevant shipping charges. If the mare aborts or fails to conceive, she may return during the current breeding season. If WPH deems it too late in the season to re-breed a mare during the current season, WPH may permit the mare to be bred the following year. All re-breed fees and all relevant shipping charges MUST be paid in advance of re-breed. If the Mare Owner/Agent fails to re-breed the mare the following year any and all fees become forfeited, the right to re-breed is canceled, and WPH is released from all further obligation of this contract unless provisions to the contrary have been agreed in writing and signed by both parties.
